You are obliged to communicate your personal data as they are necessary for the admission contest, for the registration of students, the deployment of activities specific to the education domain and the development of legal relations between you and University. In the case of your refusal to provide the data correctly and completely, University would have to break the specific regulations in the education domain.

The recorded data can only be used by the Operator and are shared to the following persons: the concerned person (you), in certain cases, other departments in University (e.g. Financial Accounting Department, The Human Resources Department, etc) and some Governmental institutions (e.g. Ministry of Education-RMU, REI, The General Inspectorate for Immigration)

The period of time reserved for personal data storage by University for Medicine and Pharmacy “Carol Davila”, in Bucharest is specified on the other page of this consent form. At the end of the period of time for data storage and processing, as the consent specifies, your data will be deleted from our current processes and will be archived based on the national law.

According to the Regulation (EU) no. 679/2016 you benefit from access and data intervention, freely, with the right not to be subject to a decision based solely on automated processing, including account opening.

You also have the right to object against personal data processing, to withdraw your consent and to solicit that your data be deleted without coming against the legal obligations of the University. In order to exercise your rights, you can submit a written request, signed and dated, at the University Doctoral School in the General Direction of the University Secretariat, located in no. 7, Dionisie Lupu Street, District 2, Bucharest. Furthermore, you have the right to address to The National Authority for the Supervision of Personal Data Processing and to court.
